# 2022 CUFC/NHFP Funding Process

Timeline (2022)	Activity – "Project First"
January to mid-March	Solicit and select regional freight priority projects for NHFP funding competition Candidate NHFP projects due to PSRC by February 4 NHFP applications due to PSRC by February 28 (will provide ftp link) PSRC NHFP submittal due to WSDOT by March 15
Mid-March thru May	WSDOT review/scoring of NHFP applications  PSRC work with FAC to identify roadways for CUFC designation
June - July	PSRC Board review / approval of CUFC list
Mid-July thru mid-August	WSDOT/PSRC review final submittal, FHWA review and certify designations
Mid-August	WSDOT notify project owners of selection process for FY 21-23 biennium*

<sup>\*</sup>Fund utilization contingent upon FHWA approval of freight investment plan by December 2022



### NHFP Process – Next Steps

- Eight candidate NHFP projects identified by jurisdictions, summarized in table
- Completed NHFP applications due to PSRC February 28
- Transportation Policy Board review/approval of list March 10
- PSRC submit application packet to WSDOT March 15 (subject to Executive Board approval of list)
- Executive Board review/approval of list March 24

# **CUFC** and NHFP - Two Overlapping Tracks

NHFP Funding Competition	CUFC Designation Process
PSRC submit list of candidate projects (and project sponsors complete WSDOT application) by mid-March	CUFC designation recommendations confirmed by mid-July

### **CUFC Process**

### Federal Requirements for CUFC Designation | PSRC'S 2016 CUFC Process

- Public road located in urbanized area, which meets one or more of the following four elements:
  - Connects an intermodal facility to the PHFS, interstate system, or an intermodal facility
  - Located within a corridor of a route on the PHFS and provide an alternative highway option important to goods movement
  - Serves a major freight generator, logistic center, or manufacturing and warehouse industrial land
  - Is important to the movement of freight within the region, as determined by the MPO or State

FHWA encourages states to consider first/last mile connector routes from high-volume freight corridors to freight-intensive land and key urban freight facilities, including ports, rail terminals, and other industrial-zoned land.

#### Two-step approach

- Initial screening using available data to identify candidate corridors based on following criteria:
  - T-1 / T-2 freight corridor
  - Serves as first/last mile connector between intermodal facility and PHFN
  - Connects to large industrial/warehouse centers (minimum 200-acre industrial area within ¼-mile distance
- Secondary screening to narrow down and identify segments with active freight projects



## Proposed 2022 PSRC CUFC/CRFC Process/Schedule

- Feb 25 PSRC will send out short form to agencies, by which to identify candidate corridors for CUFC designation, and provide relevant summary information
- March 25 Completed CUFC nomination forms due to PSRC
- April 6 compiled list of candidate corridors
- April 13 FAC meeting to discuss, potentially finalize CUFC list
- May 11 hold for special FAC meeting if needed to finalize recommendation
- May-June Board review/approval of CUFC list
- July-August WSDOT/FHWA review of statewide CUFC/CRFC list
