
Purpose of the Regional Economic Strategy

- A 5-year strategic blueprint for regional collaboration around economic development
- Overseen by the Central Puget Sound Economic Development District Board
- Qualifies eligible regional organizations for U.S. EDA funding (CARES Act, ARP, others)
- Guides PSRC/EDD economic development workplan



Development Timeline

- Scoping: Early 2020
- Kick off: July 2020
- Recovery Effort Engagement: Mid 2020 - Mid 2021
- Draft Outreach & Communications: Summer 2021
- Public Comment Period: Fall 2021
- **Strategy Adoption: December 2021**

Analysis & Strategy Development

Analyzing the regional economy, identifying new industry opportunities, and developing strategies to support growth of jobs in the region.

Technical Assistance

Providing technical assistance to efforts aimed at growing the regional economy and to support partners pursuing federal economic development funding.

Amplifying Regional Efforts

Supporting efforts by regional partners to implement policies and programs that grow the regional economy.

- Industry: Cluster accelerators, tourism marketing, sustainable aviation fuels


