# 2021 Accomplishments

- Development of Draft Regional Transportation Plan
- Project Selection Task Force
- Distribution of Funding for 3 Stimulus Packages
- Completion of Puget Sound Passenger-Only Ferry Study
- Continued Ongoing Transportation Work, Including:
  - 2021 Transit Integration Report
  - Convening 8 Transportation Committees
  - Convening TPB Transit Caucus



### **Key Transportation Work Program Elements**

#### Includes:

- Ongoing core functions to meet federal and state requirements, regional policy functions
- Ongoing or new process improvements for core areas
- Potential priority areas to implement Regional Transportation Plan



### **Core Functions in 2022**

### **High Priority**

- Regional Transportation Plan adoption (on 4-year cycle)
- Project Selection for FHWA and FTA funds (on 2-year cycle)
  - Includes building new TIP
- Federal Certification (on 4-year cycle)
- FTA Triennial review (on 3-year cycle)
- Project tracking and delivery
- Consolidated Grant regional priorities



### **Core Functions in 2022**

### **High Priority**

- VISION 2050 guidance
  - Climate
  - Other transportation related topics
- Transit plan review process
- Review / monitoring of IIJA infrastructure package funding



## **Process Improvements in 2022**

### **High Priority**

- Transportation Improvement Program (TIP):
  - Upgraded project database
  - Improved application materials for monthly amendments
- Transit MOU review and potential updates

# Regional Transportation Plan Implementation

#### What's Ahead addresses:



Transit – all modes (rail, bus, ferry, specialized, etc.)	Bicycle and pedestrian	Streets and highways
Freight	Aviation	Transportation Demand Management (TDM)
ITS / Technology	Safety	Maintenance and preservation
People/engagement	Climate	Air quality
Water quality	Finance	Big ideas / What's next



#### Proposed High Priority – Start in 2022 (post May plan adoption)

- Advance access to transit work
  - Coordination between jurisdictions and transit agencies
  - Help identify roles and responsibilities/best practices
  - Pedestrian and bicycle access priorities
- Improve regional coordination on mobility for people with special transportation needs
  - Coordinated Mobility Plan strategy to involve more diverse transportation programs



#### **Proposed High Priority – Start in 2022**

- Continued coordination on state plans (e.g., Highway System Plan)
- Freight: Engage on truck parking issues, coordinate on best practices
- TDM: Develop guidance and coordinate on collaboration, integration and implementation
- Health: Continued engagement, incorporate of resources
- Water Quality: Coordinate with Puget Sound Partnership



#### **Proposed High Priority – Start in 2022**

#### Safety:

- Evaluate outcome of project selection process and criteria revisions
- Work with partners on development of guidance and best practices

#### Climate:

- Continued work with PSCAA on Regional Electric Vehicle Collaborative, development of Regional EV plan
- Continued participation in Puget Sound Climate Preparedness Collaborative



#### **Proposed High Priority – Start in 2022**

- Equity:
  - Evaluate outcome of project selection process and criteria revisions
  - Conduct equity analysis of Regional TIP
  - Work with EAC on proposed Equity Pilot Program, if approved
  - Continue agency work on Equity Dashboard, etc.



#### **Proposed 2023 or Later Start Date**

- Data Collection
  - All modes and topics
  - Update of inventories collected in 2019-2020
  - Improve data for performance monitoring
- Data Visualization Tool Maintenance
- All other specific What's Ahead items on all topics, such as regional convenings on safety, finance, future HCT, etc.
