2022 Project Extensions

Delivery Status

- As of January 31, 2022
 - ~12% delivered
- Includes draft increase of FY 2022 funds from IIJA / BIL
 - ~\$6m STP
 - ~\$3m CMAQ
 - ~\$500k TAP
 - Pending Congressional action beyond current Continuing Resolution through March 11, and negotiation of funding splits between state / regions

Rebalancing and Next Steps

- Analysis of all projects underway
- Communication to every sponsor of a 2023 or 2024 currently funded project for advancement to 2022
- Update and review of existing contingency lists
- RPEC / CW Chairs to review extension requests, forward 1-year extensions for board approval – target of March
- Target of April board action for any rebalancing needs
 - Advanced projects or new funding awards will have until July 15th for obligation deadline

2022 Project Selection Process

- Reminder of additional funds to distribute as part of 2022 process:
 - > \$2.74 of 2021 HIP funding -- more limited STP eligibility
 - > \$19.25m of 2021 CRRSAA FHWA funding -- full STP eligibility
 - Obligation required by September 30, 2024
- Finalizing distribution splits in consultation with RPEC/CW chairs
 - will communicate increased funding levels by forum to all prospective sponsors shortly
 - PSRC will monitor and align awards by year no change to project selection process other than increased amounts available

2022 Project Selection Process

- Regional FHWA competition key dates:
 - ➤ March 11 eligibility screening forms due
 - > April 11 applications due
 - April 21-22 sponsor presentations (planning on virtual)
 - May 26-27 RPEC recommendation meeting (potentially in person / hybrid)



Infrastructure Investment and Jobs Act - aka Bipartisan Infrastructure Law (BIL)

- What do we know?
 - 2022 2026 funding
 - Overall increase in funding including to PSRC formula funding programs
 - Expected April 2022 release of final funding tables
 - New formula funding programs
 - New / expanded federal discretionary grant programs

 - Details of new funding programs
 - Notice of Funding Opportunities, guidance, etc. expected to roll out in the coming months or longer
