VISION 2050 and Climate

<u>Climate Goal:</u> The region substantially reduces emissions of greenhouse gases that contribute to climate change in accordance with the goals of the Puget Sound Clean Air Agency (50% below 1990 levels by 2030 and 80% below 1990 levels by 2050) and prepares for climate change impacts.

- Policies and actions address reducing emissions and the impacts from climate change, across many sectors
- Commits to regular analysis and evaluations as part of the 4-year Regional Transportation Plan cycle
- Commits to development of a "climate wedge analysis" for full spectrum comparisons
- Discusses impacts from climate change and resilience needs and activities

Four-Part Greenhouse Gas Strategy

- Land Use: VISION 2050 regional growth strategy
- Choices: expanded and integrated regional transit network, active transportation and other multimodal investments
- User Fees: state facility tolls, transition to road usage charge in later years
- Technology: tremendous opportunity with recent and planned actions related to zero emission vehicles, Clean Fuels Standard, etc.

Reflecting:

- VISION 2050
- RTP investments
- Fuel economy improvements
- Transition to zero emission transportation system



Regional Transportation Plan

- Action item to:
 - Develop a 2030 transportation network and inputs to conduct a 2030 analysis aligned with adopted Four-Part GHG Strategy; and
 - Continue to work with partner agencies including PSCAA on implementation strategy for achieving climate goals and monitor progress.

Deadline set for this work by December 31, 2022; work is already underway



Regional Emissions Inventory

Puget Sound Regional Emissions Analysis Project

- Seven regional partner agencies
- Comprehensive update of regional greenhouse gas emissions
- "Wedge analyses" identification of scenarios and pathways for reducing emissions across all sectors of the region
- Focus on social equity, in process and outcomes
- Advances the work behind the Four-Part Greenhouse Strategy and the action called for in VISION 2050 to address emissions from all sectors (aka a "climate wedge analysis")
- Summer 2021 through December 2022

Zero Emission Transportation

Regional EV Collaboration

- Partnership project begun in 2019
- Goal = advancement of electric vehicles throughout the region, provide support to local jurisdictions
- Hosted four forums to date
- Working towards clearinghouse of data and best practices
- Coordination with Department of Commerce work under HB1287
- Future work = Regional EV / Zero Emissions Plan

Comprehensive Plan Guidance - Climate

- Addressing both mitigation and resilience / preparedness
- Will include:
 - Summary of specific VISION 2050 policies and actions
 - Definitions and clarifications
 - Best practices and examples
 - Resources and links
 - Range of level of effort

Goal for completion by early August; workshop in mid-August



Comprehensive Plan Guidance - Climate

- Guidance tailored to agency resources / level of effort / state of practice
 - Meeting jurisdictions where they are
- Specific to resilience, encouraging internal coordination with Emergency Management departments, Public Works, etc.
- No expectation that every agency will address every issue, or create complex work programs
 - Focus on particular needs in each community / jurisdiction
 - Meaningful impacts can be accomplished at all scales
