Welcome and Introductions

Peter Heffernan, Chair, welcomed everyone at 10:00 a.m. Gil Cerise, PSRC took a roll call and confirmed the members and alternates present.

Approval of Meeting Summary

The summary for the April 27, 2022 meeting was approved.

Transportation Policy Board Debrief

Gil and Peter reviewed the Transportation Policy Board meeting Thursday, June 9, 2022 that focused on the [FTA funding process and PSRC Transportation Work Program](#). The 'At Work' report for these meetings are available on the PSRC website at: <https://www.psrc.org/tpb-meetings>.

Action: Federal Fiscal Year (FFY) 2022 Annual FTA Adjustments

Sarah Gutschow, PSRC, provided an overview of the 2022 FTA Annual Adjustments process and Federal Fiscal Year (FFY) 2022 Annual FTA Adjustments for recommendation by the Committee. She reviewed the handout of proposed changes and project revisions that were discussed at the last Regional FTA Caucus meeting and recently approved by the Caucus via vote-by-email. The committee discussed and provided comments and then unanimously approved the Federal Fiscal Year (FFY) 2022 Annual FTA Adjustments to be recommended for approval by the Transportation Policy Board at their next meeting in July.

Action: FTA and FHWA Project Tracking Updates

Sarah reviewed the memo in the [agenda packet](#) and explained how the Regional FTA Caucus formed a project tracking working group to review and update PSRC project tracking policies and procedures for projects experiencing delays in obligating their regional FTA funds and/or "flexed" FHWA funds. She provided an overview of the working group's proposed updates, as recommended by the Caucus. The Committee discussed and then voted unanimously on recommending the updates for approval by the Transportation Policy Board.

Discussion: PSRC Preparation for Regional Priority Ranking for Consolidated Grant Competition

Gil and Jean Kim, PSRC, provided an overview of the upcoming Consolidated Grant regional priority ranking process for the PSRC region, including updated/revised regional priority ranking factors based on feedback from the Special Needs Transportation Committee (SNTC). Jean reviewed a timeline for completion of the process, which includes the TOC recommendation to the Transportation Policy Board sometime in December, in order to meet WSDOT's deadline of January 27, 2023. She said this will require either adjustment to the TOC meeting schedule or an agreement for TOC action via a vote-by-email. The committee discussed the situation and decided in favor of holding a special meeting in December to review the SNTC's recommendation for priority rankings, and also keep the November 30 planned meeting date. It was noted a follow-up email to the committee with information on next steps would be sent out.

Discussion: 2022-2050 Regional Transportation Plan Adoption and Work Plan

Gil reminded the committee that the 2022-2050 Regional Transportation Plan was adopted by the PSRC General Assembly on May 26, 2022. He reviewed the memo in the [agenda packet](#) that provided information on work program items related to transit such as the development of a 2030 transit network and noted that the Transportation Policy Board will be involved in development of a work plan to implement the plan. He said PSRC is asking agencies to provide their 2030 transit network data to PSRC by September 15 to allow time for review and analysis of the information for the development of the 2030 GHG targets to be completed by the end of the year. The committee discussed and provided input and suggestions on next steps for getting the information to PSRC in September. Based upon this feedback, PSRC staff agreed to send an email with the specific request to TOC members for them to share with their appropriate technical staff.
