FMSIB Freight Project Investment List

- Comprised of freight transportation projects ready for construction between now and 2028
- Excel workbook emailed to all PSRC jurisdictions on June 1
 - Includes description of eligibility and prioritization criteria
 - Includes "Project List" page to be completed by sponsors
- Sponsors requested to return completed Project List page to PSRC by June 30
- PSRC will compile regional list, provide for Board review in July, and submit to FMSIB



FMSIB Freight Project Investment List

- Eligibility Criteria
 - 1. On the FGTS or benefits the FGTS
 - 2. Under construction within next six years

- Prioritization Criteria
 - 1. Freight tonnage
 - 2. Non-state match (percentage of total cost)
 - 3. Percentage of funding committed



CUFC Designation Process

- Guided by location of freight transportation improvement projects planned for implementation, and seeking NHFP or INFRA funds, between 2022-2026
- Covers roadway segments not already on Primary Highway Freight System
- Must meet federal guidelines for CUFC
- 103 miles originally submitted have been refined to ~71 miles, which meets WSDOT's allotment of CUFC miles to PSRC region



Refinement of CUFC Designations

- List primarily refined through voluntary reductions by sponsors
- Refined list has been grouped into four tiers, in descending order of consistency with CUFC criteria
- Last segments removed from list will be provided to WSDOT on a contingency list, to be requested for consideration if additional miles are available from statewide allotment



CRFC Designation Process

- WSDOT allocated 17.1 miles per MPO/RTPO region
- Corridor must be located outside WSDOT-designated Highway Urban and Urbanized Area (mapped)
- Jurisdictions with FGTS facilities in eligible rural areas were requested to submit candidate CRFC segments by June 6
- One segment with length of 2.2 miles submitted so far
 - PSRC staff will coordinate with four Counties to determine if there are additional segments to be added (up to ~4.2 miles per county)
 - Any balance will be returned to WSDOT for statewide contingency list consideration



CUFC/CRFC Designation Process

FAC Discussion and Action Item

Review and discuss the refined candidate CUFC/CRFC* list and CUFC contingency list, and recommend list for advancement to PSRC's boards for approval.

*CRFC list may include additional segments up to average 4.2 miles per county, depending on follow-up with Counties.



Regional Transportation Plan

- 2022 Regional Transportation Plan adopted at General Assembly in May
- Freight key messages
 - Freight is an integral part of the region's multimodal transportation system
 - Accommodating freight traffic should be explicitly addressed in transportation planning and programming, including land use policy, development regulations, and roadway design and pavement standards
 - Context matters, and potential strategies and projects to address freight issues are different depending on the setting
 - Local jurisdictions should actively engage to help address truck parking issues
 - PSRC will continue to lead and participate in forums that foster regional and statewide cooperation on freight



Regional Transportation Plan

- Anticipated FAC role in RTP implementation
 - Serve as forum to compile best practices for design, management, and operation of freight transportation, and examples of solutions to freight problems within varying contexts
 - Work with PSRC to serve as a clearinghouse to help partner agencies share this information
 - Serve as forum to support partnerships to address and prioritize regional freight issues, and leverage resources to address regional freight priorities
- Development and implementation of FAC work program to support these functions will be focus of future meetings
