SUBJECT: Consolidated Grant Regional Priority Ranking Recommendations for

Projects Seeking Funding in 2023-25 Biennium/2023-27 Biennia

IN BRIEF

The Special Needs Transportation Committee (SNTC) will meet on December 6, 2022 to develop recommendations for allocating regional priority rankings for the WSDOT Consolidated Grant program.

ACTION

The SNTC is being asked to make WSDOT Consolidated Grant regional priority ranking recommendations to the Transportation Operators Committee (TOC).

The SNTC recommendation shall:

- 1. Identify which projects found in Attachment A will receive the WSDOT-allotted regional priority rankings of 5 A's, 5 B's, and 5 C's; and
- Identify which projects seeking 4 years of funding are recommended to receive
 the same regional priority ranking for 4 years (instead of 2 years of funding).
 NOTE: When a regional priority ranking is awarded for a 4-year period, PSRC
 will lose that ranking for the 2025-2027 competition in 2024.

DISCUSSION

Included as Attachment A is a list of projects submitted to WSDOT and PSRC for consideration in the 2023-2025 Consolidated Grant competition. Attachment A is organized in priority order by the column entitled "Total Number of 'Yes' Responses", reflecting the projects that most closely aligned with the regional priority factors identified prior to the competition. Projects that are tied in the ranking are arranged in alphabetical order by the project sponsor's name. Attachment A will be the basis for

SNTC to begin deliberation on recommended regional priority rankings for the 2023-2025 Consolidated Grant Program.

Overview of Applications Received

WSDOT received 16 applications by the October 27, 2022 deadline for the PSRC region.

Summary of Project Requests

- Total requests for the 2023-2025 biennium: \$10,930,011 (16 projects)
- Total requests for the 2025-2027 biennium: \$\$8,343,035 (10 projects)

The projects include a mix of operating, mobility management, and planning projects; both sustaining and new/expansion. For the 2023-2025 biennium, none of the projects applied for capital grants. More than half of the projects seek funding for a 4-year period, rather than a single biennium. This information, along with a brief description of each project can be found in Attachment A.

Funding Available for PSRC Region

WSDOT provides funding for projects seeking Consolidated Grant funds from a variety of federal and state sources. One source, the FTA Section 5310 (Enhanced Mobility of Seniors & Individuals with Disabilities) funding program, provides funding primarily for programs and services that address the mobility needs of older adults and people with disabilities. Funds from this source are apportioned by the federal government to the Seattle-Tacoma-Everett large urban area. These funds must remain within that area.

In addition to the FTA Section 5310 for the large urban area, WSDOT will provide funding to specialized transportation projects from other federal and state sources as part of the Consolidated Grant Program, including new funding available from the Move Ahead Washington state funding package.

Because the WSDOT Consolidated Grant competition is a statewide competition, specific funding amounts available to the region from these sources will not be known until the WSDOT's Consolidated Grant scoring process is complete in spring 2023.

PSRC Staff Assessment

Attachment A shows projects arrayed by an assessment that PSRC staff completed of how each project met four regional priority factors based, in part, on the PSRC's Coordinated Mobility Plan (or Regional Coordinated Transit-Human Services Transportation Plan). Attachment A identifies projects by the sponsor, project title, and

a brief project description. In addition, PSRC has provided additional information including:

- **County:** This column identifies the county or counties with some portion of the project service area or benefit.
- **Sustaining, Expansion, or New:** This is the category that projects identified themselves as in their project application.
- **Project Type:** This identifies operating, capital, mobility management, or planning per information found in applications.
- Variance Between 2021-23 vs. 2023-25 (%): provides % changes in the requested amount of funds compared to the 2021-2023 biennium, if applying for sustaining.
- Amount of Funds Requested: Three columns are provided that identify the amount each project requested for the 2023-2025 and the 2025-2027 biennia and totals.
- % of Match 2023-2025: Provides the percentage of the local match secured for the 2023-2025 biennium
- **2-Yr/4-Yr:** These columns identify if the application is seeking funding for a single biennium (2 years: 2023-2025) or for two biennia (4 years: 2025-2027).

Attachment A also includes the PSRC assessment of the four factors used to initially rank the projects. A description of each individual factor is found in Attachment B. The "Total Number of 'Yes' Responses" column provides a summary number of "Yes" responses provided to all four factors. PSRC staff conducted this initial review of projects in a consistent manner using only information provided by the applicants in their applications and from sponsor presentations held in November 2022. PSRC will describe the process used to review the applications in association with the four factors at the deliberation meeting. The total number of projects are arrayed as follows:

- 3 projects received 4 Yes responses
- 8 projects received 3 Yes responses
- 3 projects received 2 Yes responses
- 2 projects received 1 Yes responses

The initial review results will be the starting point for the deliberation at the December 6 meeting. There will not be debate or discussion on changing these results. Applicants have an opportunity to meet with PSRC to review and discuss results after the recommendation process is complete.

Additional Factors for Consideration to Assist in Developing Recommendations In addition to the initial assessment, the SNTC has discussed additional factors to take into consideration to help create a recommendation for the regional priority rankings. Those that have been used for the last biennium can be found in Attachment B.

At the past SNTC meeting, the committee agreed to consider adding a new Equity criterion as an additional factor. Based upon SNTC discussion, staff prepared some information to share with SNTC at the December 6 meeting. Information related to equity can be found in Attachment H. The committee also agreed to provide information related to the Performance Measures and Targets criterion used in the past. Given the effects of the pandemic on achieving targets and the likelihood that objective factors associated with this topic are unlikely to produce a meaningful distinction among projects, PSRC staff recommended against using this factor in their initial assessment. However, the committee may consider the use of program/project performance as part of the additional factors for consideration in deliberation. Information related to the project-level performance for sustaining projects is included in Attachment I. Please note that due to incomplete data available for mobility management projects included in applications, staff was able to provide information for only operating projects.

Attachments H and I are provided for additional resources to help with recommendation discussion. The committee can decide whether or not to use the additional information provided by PSRC at the meeting.

PSRC will lead a discussion of whether to add to these additional factors prior to opening the discussion on recommendations at the meeting.

Regional Priority Rankings

Meeting procedures for the December 6, 2022 meeting are included in Attachment C. Part of the SNTC's charge at this meeting will be to decide on the allocation of regional rankings for the WSDOT 2023-2025 Consolidated Grant program.

WSDOT has not changed the 21 regional ranking allotments for use in the PSRC region (7 A, 7 B, 7 C). Of this total, 6 projects received regional rankings that cover projects that were funded for four years (through June 2025) in the last Consolidated Grant competition (see Attachment D for more information). This leaves PSRC with 15 ABC rankings to submit to WSDOT. The regional priority rankings the SNTC shall consider include:

- 5 A's
- 5 B's
- 5 C's
- Unlimited D's

A's are worth the most points on top of an application's statewide score and B's are worth more than C's. Please note that D rankings are not worth any points. Although the regional priority rankings help determine which projects are likely to be funded, the final award decision will be made by WSDOT based on the statewide evaluation process.

Projects that were awarded four years of funding and the amounts they were awarded in 2021 for the 2021-2023 and 2023-2025 biennia are included in Attachment D.

Attachment B: PSRC Regional Priority Ranking Process

The Washington State Department of Transportation (WSDOT) awards state and federal funds to specialized transportation projects/programs through its Consolidated Grant competition. As part of this process, regional planning organizations (Regional Transportation Planning Organizations or Metropolitan Planning Organizations) participate in the scoring process by providing regional priority rankings for projects/programs applying for Consolidated Grant funds from within their respective regions. As a Metropolitan Planning Organization (MPO), the Puget Sound Regional Council (PSRC) provides regional priority rankings, expressed in WSDOT's designated letter grade format, for the projects/programs seeking funds in King, Pierce, and Snohomish counties.¹

WSDOT allocates a fixed number of ABC rankings to each region for distribution to projects in the competition. Points associated with each regional priority ranking with an A through C ranking are added to a score that the state produces for each project seeking funding.

For the 2023-2025 biennium, the PSRC region will be able to distribute 15 regional rankings worth points in the competition (5 A's, 5 B's, and 5 C's) and an unlimited number of D rankings (which are worth 0 points) that can also be submitted and allow a project to be considered for funding through this grant process. Sponsors can apply for either two years (July 1, 2023-June 30, 2025) or four years (July 1, 2023-June 30, 2027). Projects that WSDOT awards for four years will receive the same regional priority ranking from PSRC for both biennia and do not have to re-apply after the first biennium unless the state determines otherwise.



¹ Kitsap County is a member of both PSRC and the Peninsula RTPO. Kitsap County participates in the WSDOT Consolidated Grant regional ranking process through the Peninsula RTPO.

Special Needs Transportation Committee



PSRC's Regional Priority Ranking Factors

PSRC's Regional Priority Ranking Factors are designed to help implement the <u>Regional Coordinated Mobility Plan</u>, the region's Coordinated Transit-Human Services Transportation Plan. The objective of the regional priority ranking factors is to allow staff to identify how well projects address regional priorities for specialized transportation. This evaluation helps guide the Special Needs Transportation Committee (SNTC) in developing its recommendations for regional priority rankings for projects/programs seeking funding.

PSRC staff will review applications for how well they address the regional priority factors listed in Table 1. Projects will receive simple "Yes" or "No" answers for each factor, rather than numeric scores or grades:

- A "Yes" response indicates that the project application addresses the factor; and
- A "No" response indicates that a project application does not adequately address the factor.

Applicants seeking regional priority rankings from PSRC are also required to provide a short presentation. At this session, SNTC voting members (or alternates of the voting members) and PSRC staff will attend for Q&A. The quality of the presentation will not be evaluated. Currently, the presentation session is scheduled for November 16 (9:00am-4:00pm). The exact dates and times will depend upon the volume of applications received by the October 27, 2022 deadline. Sponsors will be notified about the length and the order of the presentations before the meeting. PSRC staff will also use the information heard from sponsor presentations to determine the final Yes/No responses for each factor.

A summary of review results will be provided to the SNTC as a resource for their <u>December 6, 2022, deliberation</u> <u>meeting</u>, at which the committee will discuss and make recommendations for the regional priority rankings. In addition, sponsors have the opportunity to provide information that is not addressed in the application for additional consideration in the recommendation process, by using "Additional Factors for Consideration in Deliberation" developed by the committee at the meeting.

Table 1 outlines the regional priority ranking factors along with a description of how PSRC staff will evaluate each factor found under the sub-heading, "Evaluation Method." The topics listed below are not listed in any priority order. No weighting will be applied to any factor.



Table 1: PSRC Regional Priority Ranking Factors

Regional Priority Ranking Factors

Guidance for which WSDOT application question addresses this factor

Factor #1: Project Type (Preservation vs. New or Expansion)

Is the application for funding needed to support the ongoing operations of an existing program? This includes fleet replacement and maintenance, or other capital needs to support an existing program at existing service levels.

Evaluation Method: Only preservation and capital projects that are supporting existing programs at existing service levels will receive a "Yes." New or expansion projects will receive a "No" for this factor.

If your project is an operating project: the response should be provided in the "<u>Need for Service</u>" section under the heading "Summary of Project Information."

If your project is a capital, mobility management, or planning project: must include whether they are the preservation of an existing program in a brief statement under the "Proposed Scope/Description of the Work" section under the heading "Scope of Work."

Factor #2: Support for PSRC's Coordinated Mobility Plan

Does the application support PSRC's Coordinated Mobility Plan by addressing at least one "High" Prioritized Strategy as identified in the plan?

Evaluation Method: Only applications showing that they adequately address at least one "High" Prioritized Strategy found on PDF page 42-44 will receive a "Yes." Applications failing to address this component of the Coordinated Mobility Plan, or only addressing "Other" Prioritized Strategies, will receive a "No" for this factor.

Address how your project will align with at least one "High Prioritized Strategy" in the "Need" section under the heading "Scope of Work."

Evaluation Method: Applicants that adequately explain the uniqueness of their services and how their projects do not duplicate other existing services for target populations, including those provided by public transportation operators (fixed-route, demand response, travel training, etc.) will receive a "Yes." Applicants that do not provide an explanation or respond there are no similar services or programs without an explanation, will receive a "No" for this factor.



Regional Priority Ranking Factors

Guidance for which WSDOT application question addresses this factor

Factor #4: Financial Sustainability

Does the application demonstrate that it is providing more than the federal minimum required match from local sources in its project budget?

Evaluation Method: Operating projects seeking a federal/state funding amount less than 50% of their net project cost (demonstrating more than 50% of the net project cost can be fulfilled with local match) will receive a "Yes." Capital and mobility management projects seeking federal/state funding amount less than 80% of their net project cost (demonstrating more than 20% of the net project cost can be fulfilled with local match) will receive a "Yes."

If your project is an operating, mobility management, or planning project: provide information in the "Revenue and/or Match" section under the heading "Budget."

If your project is a capital project: provide information in the "<u>Match/Revenue Sources</u>" section under the heading "Capital Budget."



Additional Factors for Consideration in Deliberation

In addition to the four Regional Priority Ranking Factors noted in Table 1, the Special Needs Transportation Committee (SNTC) will have an opportunity to identify additional factors to use during their deliberations. The SNTC identifies the additional factors that they may take into consideration during deliberations on regional priority recommendations. However, the factors should be different than the Regional Priority Ranking Factors, which are used for the initial review. Table 2 provides a list of additional factors determined by SNTC and used at the last regional priority ranking deliberation meeting for the 2021-2023 biennium. This list can be retained, updated, or replaced based on SNTC feedback during the December 6 deliberation meeting. The topics listed below are not listed in any priority order.

Table 2. Additional Factors for Consideration in Deliberation Used for the 2021-2023 Biennium

Geographical distribution of regional priority rankings	This factor addresses the distribution of regional priority rankings over the three counties participating in the Consolidated Grant competition in the PSRC region.
Project types	This factor addresses the variety of project types being recommended for regional priority ranking (e.g., mobility management, operating, and capital projects).
Agency equity	This factor addresses the number of projects recommended to receive funding by an agency.
Compelling cases for agencies with limited resources	This factor addresses projects that provide valued services and programs, but which are challenged to provide the minimum local match. Small agencies and/or community-based organizations might have less local support compared to larger agencies that have local partners providing sufficient local matching funds or local governments/transit agencies that have their own tax bases.
Strategic application of federal/state funds	This factor includes stakeholders' assessment of possible program eligibility for state/federal funding programs found within the Consolidated Grant program.
Coordination	This factor addresses projects that work together to make the most efficient use of limited resources. There are many levels of coordination, ranging from the basic sharing of training resources to the full integration of services. The Committee can discuss the full range of coordination for this topic.



Attachment C: Meeting Procedures for Special Needs Transportation Committee 2023-2025 Consolidated Grant Regional Priority Ranking Recommendations

The meeting will begin promptly at 9:00am on Tuesday, December 6, 2022. The meeting will be conducted in a hybrid format, with in person attendance offered in the PSRC Board Room, and virtual participation using Zoom. The committee will take necessary breaks at regular intervals, as needed, until 2:00pm or until the committee is able to produce a recommendation for the allocation of regional priority rankings, whichever comes first.

PURPOSE AND OUTCOMES

- The committee will recommend regional priority rankings for projects seeking funding from WSDOT's 2023-2025 Consolidated Grant program. WSDOT has allocated 21 ABC rankings to PSRC for 2021-2025 and the following regional priority rankings remain in the PSRC region for the 2023-2025 biennium:
 - o 5 "A" rankings
 - o 5 "B" rankings
 - o 5 "C" rankings
 - Unlimited "D" rankings.
- For projects seeking four years of funding, the committee shall identify whether to allow the regional priority ranking to be used for the four years or only for a twoyear period. NOTE: When a regional priority ranking is awarded for a 4-year period (2023-2025 & 2025-2027), the MPO/RTPO loses that ranking for the 2025-2027 competition in 2024. In other words, a regional priority ranking used for four years does not become available to the region again until that four-year period is over.
- The committee will submit its recommendation to PSRC's Transportation Operators Committee (TOC).

EXPECTATIONS

Meeting Decorum

 Committee members agree to keep an open mind and identify their interests and objectives.

- Committee members agree to respect each other's opinions and make an effort to understand and accurately characterize the views of other members.

 Members will operate in a consistently constructive manner.
- Discussion will be conducted in a professional way with a focus on project merits.
- Although both informational and voting committee members and alternates may
 participate in the discussion, only voting members or their alternates (in the
 absence of the voting member) will be permitted to make motions or take votes.
 No questions or comments will be permitted from other staff, other than PSRC or
 WSDOT staff, during the committee deliberations.
- Project sponsors may be present for the deliberations. However, out of fairness
 to project sponsors unable to attend in person, project sponsors will not be asked
 to respond to project-specific questions posed by committee members. Instead,
 committee members will rely upon applications, presentation materials, and other
 information provided by the applicant in advance of the meeting to develop
 recommendations.
- The committee will conduct their deliberations in an open discussion with no predetermined outcome. No pre-determined regional priority ranking packages will be considered.
- During breaks, participants will not discuss regional priority ranking recommendations.
- The committee shall strive to reach informed consent on the issues before them, through a cooperative problem-solving process. Consensus is not unanimity, but substantial agreement that the group can move forward. Voting shall be transacted by motion that may be made by any voting member in attendance (or alternate if the voting member is absent), including the chair, and shall require a second. Voting on all motions shall be by a call for a roll. Then the facilitator shall call for the vote of each member and the vote shall be recorded.

Meeting Procedures

- PSRC staff will facilitate the meeting, to enable the chair to participate in discussions.
- PSRC staff will provide a summary of how project applications addressed factors
 that the region takes into account for regional priority rankings to the committee a
 week prior to the deliberation. The summary results will show an initial ranking of
 projects based upon those factors. The results of this summary are final and
 there will be no discussion or debate on an individual project.

- The facilitator will ask if any project sponsors wish to voluntarily withdraw any projects or provide any other relevant information to inform the regional priority ranking recommendation.
- After a presentation of the materials provided to the committee, the facilitator will
 ask the committee before beginning the project recommendation discussion if
 there are any additional factors for consideration the committee wishes to use to
 help in their decisions, besides the regional priority ranking factors that are
 already provided.
- The committee will openly discuss all project requests for consideration. If a
 higher ranked project is skipped over or provided a lower priority ranking than
 would otherwise be considered by the initial ranking, an explanation is required,
 e.g., meeting the agreed upon additional factors for consideration.

POST-MEETING EXPECTATIONS AND OUTCOMES

- PSRC staff will present the recommendation to the TOC for consideration at the December 15, 2022 meeting. Committee members are expected to brief TOC representatives from their county, as appropriate. The SNTC representative to the TOC will also attend the TOC recommendation meeting as well but are nonvoting members of the TOC.
- PSRC staff will prepare the meeting summaries, including the priority ranking results and committee recommendations, for reporting to the TOC, the Transportation Policy Board (TPB), and the Executive Board.
- There are public comment opportunities at TPB and Executive Board meetings.


