## **Purpose & Outcome of Meeting**

- Committee shall recommend regional priority rankings for projects seeking funding from the WSDOT Consolidated Grant competition.
- 15 regional rankings are available for the 2023-25 biennium for PSRC:
  - o 5 A's
  - o 5 B's
  - o 5 C's
  - Unlimited D's



## Purpose & Outcome of Meeting (continued)

- For projects seeking 4 years of funding (for 2023-2027), the committee shall identify whether to allow the regional priority ranking to be used for 4 years or only for 2 years.
  - When a regional priority ranking is awarded for a 4-year period, PSRC will lose that ranking for the 2025-2027 competition in 2024.
- The committee will submit its recommendation to PSRC's Transportation Operators Committee (TOC).




## **Today's Meeting Procedures (continued)**

- Project sponsors announce voluntary withdrawals or any additional relevant information to inform the priority ranking recommendations.
- Review "Additional Factors for Consideration in Deliberation" as part of the deliberation.
  - The committee will identify any additional factors to be considered for the 2023-2025 biennium
- The committee will openly discuss all project requests. An explanation is required for raising up or lowering projects based on initial sorting. The committee members shall use "additional factors" to explain.
- <u>Action</u>: Recommend regional priority rankings to projects for TOC's consideration

# Summary of Regional Priority Ranking Review Attachment 3-A

#### Total Requests for 2023-2027: \$19.2M in 16 project applications received by the October 27, 2022 deadline.

• 10 projects are seeking funding for a 4-year period.

## **Regional Priority Ranking Factors**

#### 1. Project Type (Preservation vs. New/Expansion)

• Evaluation Question: Is the application for funding needed to support the ongoing operations of an existing program?

#### 2. Support for PSRC's Coordinated Mobility Plan

 Evaluation Question: Does the application support PSRC's Coordinated Mobility Plan by addressing at least one "High" Prioritized Strategy as identified in the plan?



## **Regional Priority Ranking Factors (continued)**

#### **3. Uniqueness of Service**

 Evaluation Question: Does the application provide information demonstrating that there are no other operating or mobility management programs serving the <u>same target populations within the same</u> <u>geographic area?</u>

#### 4. Financial Sustainability

 Evaluation Question: Does the application demonstrate that it is providing more than the federal minimum required match from local sources in its project budget?



## **Additional Factors for Consideration in Deliberation**

Additional Factors used in developing regional priority ranking recommendations in 2021 are found in **Attachment 3-B (PDF page 18)**.

These are the factors that the committee used to explain their recommendation for the 2021-2023 biennium.

Before the deliberation, the committee will review and decide upon a final list of additional factors for regional priority ranking recommendations for the 2023-2025 biennium.
