# CALL TO ORDER

The meeting was called to order at 10:00 a.m. by Councilmember Prince.

# COMMUNICATIONS AND PUBLIC COMMENT

Alex Tsimerman provided public comment.

#### **CHAIR'S REPORT**

Chair Prince announced Kitsap County Commissioner Ed Wolfe was retiring from office and this will be his last meeting. The board thanked Commissioner Wolfe for his contributions to the region.

#### **DIRECTOR'S REPORT**

Paul Inghram, Director of Growth Management, thanked board members Patience Malaba and Angela Rozmyn for being part of the Regional Transit Oriented Development event held October 21. The event included a successful webinar and three afternoon of walking tours. On October 26, PSRC hosted a well-attended webinar on Housing and Racially Disparate Impacts. Mr. Inghram shared that a Peer Networking event on stormwater parks is scheduled for Nov 4. He also shared dates for other upcoming PSRC webinars.

Mr. Inghram shared that a joint board session on institutional racism is scheduled on November 30, 10-11:30 a.m. The GMPB will not meet in December.

# STORMWATER PARKS PROJECTS AND GUIDANCE

Erika Harris, Senior Planner, provided an overview of what defines a stormwater park and its benefits for the environment, community, and water quality. Ms. Harris shared details of the National Estuary Program grant that PSRC received to promote stormwater parks; PSRC's stormwater parks webpage provides additional details and handouts on lessons learned. She highlighted the stormwater parks from the City of Arlington, Kitsap County's Manchester Stormwater Park, and the City of Shoreline. Ms. Harris shared that the grant allowed PSRC to provide technical assistance for six stormwater parks and noted the criteria for selecting sites for technical assistance.

Leah Mikulsky, City of Woodinville, a recipient of PSRC's technical assistance, shared details of the city's stormwater park project and its benefits. Ms. Mikulsky shared how the technical assistance was helpful to a smaller jurisdiction and lessons learned.

Bethany Steadman, AHBL, shared details of stormwater park projects from the City of Kirkland, Kitsap County, Lynnwood, and Puyallup.

Board members discussed project details in their jurisdictions; how stormwater parks support urban growth; parks as a community feature; partnerships to address state highway runoff near lakes; stormwater management on a watershed level, and projects that use concrete rather than integrating a drainage system.

On Friday, November 4, PSRC will host a Peer Networking event on stormwater parks.

# **REGIONAL TOD EVENT RECAP**

Laura Benjamin, Principal Planner, shared that this year's transit-oriented development (TOD) event was focused on equitable growth and ensuring transit communities are accessible to all people. The TOD event was supported by the work and coordination of the Regional TOD Committee. Ms. Benjamin shared details of the event webinar and guided walking tours. The webinar portion of the event had a nationwide audience of nearly 300 attendees. Walking tours throughout the region hosted smaller groups.

Ms. Benjamin highlighted PSRC's newly established compensation program, which helped support diversity and inclusion of panelists, speakers, and walking tour hosts. It allowed for participation of those who may not be compensated for their time but are actively engaged in TOD conversations.

Board members Patience Malaba and Angela Rozmyn, who attended, shared thoughts on the event.

## 2022 HOUSING INCENTIVES AND TOOLS SURVEY

Ms. Benjamin shared that many cities and counties have been working to expand housing incentives and tools through housing action plans and in their comprehensive plan updates. PSRC has been surveying local jurisdictions to understand what housing actions are being taken.

Associate Planner Ben Kahn shared findings from the 2019 Housing Incentives and Tools Survey (HITS) noting it helped establish a baseline of housing incentive programs and successful housing action plans. Mr. Kahn then shared preliminary findings and key trends from the 2022 HITS.

Staff are continuing to solicit survey responses, hoping to hear from all jurisdictions in the region. Results will be incorporated into a comprehensive report available in early 2023. The survey results will provide best practices for addressing housing and inform regional housing programs.

Members shared perspectives on meeting housing demands, and how PSRC will inform local jurisdictions about tools available and the current tools that are working. Staff shared the resources PSRC provides to member jurisdictions, including information on housing tools through the Housing Innovations Program website. Members discussed allowing higher densities and reduced parking requirements. Members also discussed the need for information on which tools and strategies are having the most impact on housing issues. Staff shared efforts to catalog the tools available to jurisdictions, and a new place typology will help tailor housing tools to local conditions.

Members also shared concerns about information reaching elected officials and offered to support PSRC staff outreach. Staff shared current plans to reach out to local elected officials and planning commissions while supporting the comprehensive plan update.

# HOUSING PUBLIC OPINION SURVEY

Mr. Inghram shared that PSRC, in conjunction with the Department of Commerce, conducted a public opinion survey to understand what people think about housing and affordability.

Kate Gunby and Chien-Yu Chen, PRR, shared initial results of the public opinion survey. They covered details of the methods of the survey, noting prioritized groups in the categories of age, language, income, renters, and those experiencing homelessness. Overall, the survey showed that homelessness and housing costs/rents are the toprated problems in Washington state. The vast majority want more housing options available for people in their community.

The survey period will conclude November 6. Data will be finalized and analyzed, with a full report complete in December. The results will be shared with the Executive Board and be provided to members of the GMPB.

## **NEXT MEETING**

The Joint Board Session is scheduled for November 30. The next regular GMPB board meeting is scheduled for January 5, 2023.
