

2022 Bike/Ped Accomplishments

- ✓ Completed active transportation sections of 2022-2050
 Regional Transportation Plan (adopted May 2022).
- Incorporated bike/ped implementation action items into draft priorities and timelines, based on board feedback.
- Began work on priority items: repackaged Active Transportation Plan, bike/ped facility typology update, and transit access guidance update.
- Provided input on related PSRC processes, such as TAP project selection and Household Travel Survey.
