IN BRIEF

The bylaws of the Central Puget Sound Economic Development District state the board shall have an Executive Committee, which is appointed by the President and ratified by the board.

RECOMMENDED ACTION

DISCUSSION

The Central Puget Sound Economic Development District bylaws state "The Executive Committee, to the extent provided in these Bylaws, shall have and exercise the authority of the Board of Directors in the management of the affairs of the Corporation between regular meetings of the Board; Provided, that such committee shall not have the authority of the Board of Directors in reference to altering, amending, or repealing the Bylaws; or, amending or repealing any resolution of the Board of Directors which by its terms provides that it shall not be amended, altered or repealed by such committee. The Committee shall be appointed by the President with ratification by the Board." The Executive Committee serves a one-year term.

Incoming President, Axel Strakeljahn, nominated a slate of Executive Committee members at the beginning of his term at the February 2022 meeting, which was ratified by the EDD Board. Subject: 2024 PSRC Office Relocation

IN BRIEF

PSRC's office lease at Waterfront Place expires in early 2024. PSRC executed a new lease for space on the fifth floor of 1201 Third Avenue in July 2022, and the agency expects to move into the new office in late 2023 or early 2024.

DISCUSSION

PSRC's current leasing of the fifth-floor office space at Waterfront Place expires in early 2024. For several reasons, remaining at Waterfront Place proved to be infeasible. Staff began exploring new lease options beginning in March 2021. Staff conducted market research with the advice and counsel of a corporate real estate broker, who leveraged the market to enable PSRC to negotiate competitive proposals both in terms of rental rate and tenant improvement allowances. Over ten different properties were viewed, and multiple offers were solicited from late 2021 to July 2022. PSRC executed a new lease for space on the fifth floor of 1201 Third Avenue in July 2022.

The new office space will allow for a large board room that will be flexible in set up and size, depending on the number of in-person occupants. In addition, the space will provide more meeting rooms and more flexible space to support the hybrid work environment envisioned for the future. The space improves PSRC's space efficiency while accommodating potential future growth.

The new lease will commence on January 1, 2024. Tenant improvements to the space will be constructed in 2023. Moving new and existing equipment and furniture will occur in late 2023 and early 2024. Board meetings in December 2023 and January 2024 may need to be remote during that transition period. The Operations Committee has been overseeing the progress of space selection and lease negotiations.

Subject: VISION 2050 & Housing

IN BRIEF

Housing access and affordability are key policy areas in <u>VISION 2050</u>, the region's long-range plan for growth. The board will be provided an overview of VISION 2050 with a focus on the <u>Regional Housing Strategy</u> and upcoming regional housing assistance work.

DISCUSSION

VISION 2050 is the long-term planning strategy for the central Puget Sound region. It provides a framework for coordination across jurisdictions and establishes an integrated approach to growth management, housing, transportation, economic prosperity, and the environment. Like a local comprehensive plan, VISION 2050 includes goals, multicounty planning policies (MPPs), and implementation actions. It also sets forth the Regional Growth Strategy that provides numeric guidance for planning for population and employment growth reflected in countywide growth targets and local comprehensive plans.

VISION 2050 Implementation

PSRC's General Assembly adopted VISION 2050 in October 2020. Following adoption, PSRC has worked to implement actions from the plan (see Attachment A), often in coordination with state, local, and other regional agencies. Implementation has focused on two broad sets of actions: The update and adoption of regional plans; and work to support the 2024 local comprehensive plan updates.

Implementation through regional planning included the adoption of the Regional Economic Strategy, the Regional Transportation Plan, and the development of a Racial Equity Strategy. A Regional Housing Strategy was also developed and adopted in February 2022. As the 2024 deadline for local plan updates approaches, PSRC is focusing on supporting implementation through local efforts.

The Regional Housing Strategy

The Regional Housing Strategy is a "playbook" of regional and local actions to preserve, improve, and expand housing stock in the region. The aim is to make a range of affordable, accessible, healthy, and safe housing choices available to every resident and to promote fair and equal access to housing for all people.

The strategy identifies roles for PSRC, cities, counties, and other stakeholders to implement the strategy, with a focus on providing resources and support for the 2024 local comprehensive plan update. By providing data, guidance, and technical assistance, PSRC supports jurisdictions in their efforts to adopt best housing practices and establish coordinated local housing and affordable housing targets.

The Regional Housing Strategy is an opportunity to develop overarching regional approaches that increase consistency and collaboration in housing work, and local and individual actions that can be tailored to communities based on needs and opportunities.

Annual Monitoring Report

The 2022 Regional Housing Strategy Monitoring Report provides a snapshot of key housing measures in the region, as well as longer-term trends and case studies. Data in the report shows the region's progress on the housing crisis since the Regional Housing Strategy was adopted earlier this year. The report's findings center on general affordability measures, supply, stability and subsidy. A key takeaway from the data is that, although more is being done to address housing access and affordability than in past decades, historic investments and changes are needed to see significant improvements in the housing crisis.

Regional Housing Strategy monitoring will help to shape and focus regional housing assistance and local work.

Public Opinion Survey

To learn more about public opinions on housing, PSRC and the state Department of Commerce collaborated and contracted with PRR to develop and conduct a statistically valid public opinion poll. PRR surveyed individuals from the four counties in the central Puget Sound region and eight additional counties in eastern and western Washington. The survey collected responses from 4,329 people conducted October 15 to November 6, 2022.

This collaborative effort allows for a better understanding of the public interest in housing strategies both within the PSRC region and statewide. The number of responses is sufficient to look at the region as a whole and major subareas, as well as to assess demographic differences, such as age, housing tenure, and income. Survey results will aid PSRC in the implementation of housing strategies and provide useful information for local governments as they update the housing elements of their comprehensive plans.

Housing Opportunities by Place Typology

During the development of the Regional Housing Strategy, PSRC board members and stakeholders underscored that "everyone has a role to play" and that "no two communities are alike." At the local level, places vary in their needs for housing investments and interventions. A place typology is a way to identify actions based on local conditions such as size, housing needs, market conditions, demographics, growth expectations, and staff capacity.

The Regional Housing Strategy includes an implementation step for PSRC to develop a local housing typology to identify the strategies, tools, and actions that have the most potential to make an impact in different types of places.

The draft typology will identify potential tools and action from the Regional Housing Strategy and Housing Innovations Program (HIP) for each type of place. The typology resources will be available in spring 2023.

Local Implementation Survey

PSRC fielded a survey of local jurisdictions in 2019 to better understand what housing tools were being developed and which were most effective in developing housing. Of the fifty jurisdictions that participated, over two-thirds had put in place at least one incentive to promote housing development and/or affordability and 30 had adopted density bonuses. Since 2019, many jurisdictions have completed Housing Actions Plans and are assessing their scope of housing work for their comprehensive plan updates. PSRC is fielded an update to the survey during summer 2022 that ask what additional housing work jurisdictions have completed since 2019 and what is planned for near-term implementation. The results from this survey will be available in early March 2023.

Next Steps

PSRC is continuing to implement the Regional Housing Strategy through support of local and subregional housing work, including the major comprehensive plan updates due in 2024.

Subject: Regional Equity Strategy Update

IN BRIEF

Equity is a key policy area in <u>VISION 2050</u>, the region's long-range plan for growth. A new action in the draft VISION 2050 plan (RC-Action-3) directs PSRC to develop a regional equity strategy, which is intended to make equity central to PSRC's work and to support the 2024 local comprehensive plan updates.

PSRC staff and the <u>Equity Advisory Committee</u> (EAC) have made progress on regional equity work, including co-creating elements of the <u>Regional Equity Strategy</u>, which will provide guidance to help members work in a coordinated manner towards the region's goal of providing an exceptional quality of life and opportunity for all. It will also provide guidance and training for staff to ensure the agency effectively uses its roles to advance racial equity.

DISCUSSION

Regional Equity Strategy

Based on feedback from PSRC boards and committees as well as various stakeholders from around the region, staff worked with the Equity Advisory Committee to help shape both the Regional Housing Strategy and Regional Transportation Plan. Additionally, staff has been working with the Equity Advisory Committee to co-create the Regional Equity Strategy. The strategy will include components such as:

Capacity Building

- Learning Opportunities
- Prioritizing Equity
- Inclusive Procurement

PSRC will share how feedback from the EAC was incorporated into the Regional Housing Strategy, Regional Transportation Plan, and Regional Equity Strategy. Additionally, staff will share the 2023 workplan for the EAC.

The next meeting of the Equity Advisory Committee is being held on March 2, 2023. Members will walk through a simulation of the current PSRC scoring and evaluation process and evaluate transportation projects from previous years to get more familiar with the process.

Americas Competitiveness Exchange

From May 14-19, 2023, the Americas Competitiveness Exchange (ACE) is coming to the Greater Seattle region. ACE brings together up to 60 senior-level government, business, policy, and economic decision-makers from across the Americas and beyond to experience first-hand the diverse range of projects, strategic investments, public-private partnerships, and best practices from a particular region's economic, innovation and entrepreneurship ecosystem.

Visiting delegates will spend a week visiting businesses, organizations, universities, and important cultural sites across King, Kitsap, Pierce and Snohomish Counties. PSRC is leading the coordination of this visit, with the support of the Washington State Department of Commerce.

Economic Development technical assistance

Jurisdictions are beginning the work to update their Comprehensive Plans by December 2024. These plans will cover a jurisdiction's land use, housing, utilities, transportation, essential public facilities, and economy. Jason Thibedeau, Economic Development Program Manager at PSRC, has been working to support local jurisdictions as they begin the planning process for their economic development elements, recently providing presentations to the Snoqualmie Economic Development Commission and the Lakewood Planning Commission.

EDD Board develops workplan for 2023

At its December meeting, the EDD Board developed a set of <u>Focus Areas</u> for board and staff efforts in 2023. The EDD board is responsible for developing and maintaining a Regional Economic Strategy for the central Puget Sound region. Economic Development Focus Areas for 2023 include; areas of analysis and strategy development, technical assistance, and working to amplify important economic development efforts in the state and region.

PSRC Summer Planning Academy

In summer 2023, staff are conducting a youth engagement program called PSRC Summer Planning Academy (SPA). The goals of a structured youth engagement program include: Introducing individuals to the planning process and profession at an early age; Engaging young people on a regular basis to provide input on PSRC's

policies and programs, and; Promoting equity in the region by actively recruiting and engaging youth from diverse backgrounds including Black, Indigenous, and people of color (BIPOC) communities, low-income residents, and people with disabilities.

The program is open to any rising high school student in the region and will take place on four consecutive Fridays beginning July 21, 2023. Each day will introduce students to planning topics in the region, introduce them to panelists and speakers that are contributing to this work, and include site visits to relevant locations across the four counties. PSRC receives \$4.9 Million Federal Grant to Work Toward Reaching Zero Road Fatalities by 2030

The US Department of Transportation has announced that Puget Sound Regional Council (PSRC) will receive nearly \$4.9 million through the U.S. Department of Transportation's Safe Streets and Roads for All (SS4A) Grant Program. The grant will support development of a Regional Safety Plan and local safety plans for the cities of Burien, Everett, Kent, Redmond, and Tukwila, and Pierce County, Washington. Subject: Draft Public Participation Plan

IN BRIEF

PSRC staff have been working with the Equity Advisory Committee to update the Public Participation Plan. A draft version is being reviewed by PSRC boards this month with the goal of releasing the plan for public comment from March 23 to May 8, 2023.

DISCUSSION

The Puget Sound Regional Council maintains a Public Participation Plan to establish consistent procedures to ensure people have reasonable opportunities to be involved in the regional planning process and provides examples of the types of tools and techniques the agency may use to communicate with the public. Public Participation Plans are a federal requirement for Metropolitan Planning Organizations. PSRC's Public Participation Plan was last updated in 2018.

The new draft Public Participation Plan has an enhanced focus on equity, updated goals, desired outcomes and guiding principles, as well as a suite of new techniques and tools for engagement. The new plan also features an expanded emphasis on public participation related to the Regional Economic Strategy.
