Discussion: PSRC Transit Access Working Group recruitment

Discussion: Transit-related measures on the PSRC RTP Dashboard

Craig Helmann, PSRC shared transit-related performance metrics found in the RTP Dashboard. Craig took comments from TOC members at the meeting for improvement and update of the transit-related dashboard metrics. It was also mentioned that PSRC is interested in additional transit agency suggestions for improvements or additions to transit-related metrics that can be tracked and reported over time. PSRC staff will

Discussion: Transit Development Plans in the Region – PSRC plan review and data collection processes

Erin Hogan, PSRC, shared PSRC's review and assessment of transit development plans produced by transit agencies in the central Puget Sound region. PSRC has identified several key areas where the state requires transit agencies to produce as part of these plans that provide useful cross-checks and opportunities for collaboration on data collection and analysis. PSRC will initiate a more formal transit development plan review process beginning with the plans due to WSDOT by September 1, 2023. Since PSRC is interested in receiving reviews and comments on draft plans, staff requested that each agency that produces a transit development plan provide their lead staff contact information. With that information PSRC will organize a meeting to share the regional interest in review and comment on these plans.

IDENTIFYING THE USES AND SUBSEQUENT REPORTING OF THE FTA EQUITY FORMULA DISTRIBUTION

Staff has been directed to work with the Transportation Operators Committee to develop procedures to demonstrate the PSRC FTA funds distributed via an equity allocation formula are used to improve equity and demonstrably support PSRC's identified equity focus area populations, hereafter referred to as "EFAs." These procedures fall under the two categories below.

Step 1 – Project Identification

Once the distribution formula is determined, each agency must identify specific projects and amounts that are forwarded to the PSRC boards for final approval. At the point of project submittal, each agency must provide a description of how the project supports and improves equity. Staff will work with the Transportation Operators Committee to identify the specific level of detail to be provided for each project.

For TOC discussion -

Each agency will provide, for each project, the relationship to EFAs within the project area and how the project improves mobility and access to opportunities for EFAs. The expectation will be that for each project data will be provided, using PSRC support materials as necessary, and a thoughtful response regarding the benefit of each specific project to improving equity. Staff proposes to work with the TOC to provide an example response for a capital construction project and a more programmatic project such as preservation and maintenance.

Step 2 - Monitoring

PSRC has several ongoing monitoring efforts related to transit and equity data. PSRC will continue the tracking of transit ridership and service by EFAs to the extent feasible and share data in the RTP Performance Dashboard. In addition, staff will work with the Transportation Operators Committee to identify a baseline and specific metrics against which future success will be monitored.

For TOC discussion -

A baseline within this context could be the existing PSRC data previously shared regarding transit service and EFAs in the region (staff can share this information at the meeting). This could then be monitored and updated when PSRC updates the transportation network base year every four years.
