SUBJECT: Updates on the Development of the Equity Tracker

IN BRIEF

PSRC staff met with the committee three times in 2022 about the Equity Tracker: in February to provide an introduction, in April to discuss key design elements (data, context, and solutions), and in October to review feedback from members on draft webpages. In this June session, staff will report on progress made since last fall and provide updates on the development process.

DISCUSSION

Background

PSRC is developing an Equity Tracker centered on <u>VISION 2050</u>. It will use data to help measure wellbeing for different communities in our region. This resource will track progress on equity-related <u>VISION 2050</u> goals and policies and help hold PSRC and others accountable as we work towards a region where race no longer predicts life outcomes and people have improved choices and opportunities.

The Equity Tracker will complement existing PSRC <u>Data</u> and <u>Equity</u> resources, which support agency work programs and help center equity in regional plans and strategies. As a pillar of the <u>Data</u> and Research component of the <u>Regional Equity Strategy</u>, the Equity Tracker will help elevate equity in agency work. Further, it will enhance PSRC's ability to support members and stakeholders in pursuit of their own equity objectives.

PSRC staff is taking an iterative approach to develop the Equity Tracker and starting with a bounded set of priorities for the initial version. We envision subsequent versions to include additional features and functionalities.

Engagement with the Equity Advisory Committee (EAC)

In the <u>February 2022 EAC meeting</u>, PSRC staff introduced the Equity Tracker project and discussed with members about options for future engagement. Members,

 Expressed a desire to learn more about "data, context, and solutions," the three main components for each life outcome being measured and tracked; and Identified testing draft products and providing feedback on specific materials through surveys as top choices for involvement in the development process.

Based on their feedback, PSRC staff provided members with additional details on the data, context, and solutions elements of the Equity Tracker in the <u>April 2022 EAC</u> <u>meeting</u>. Subsequently, we offered an opportunity for members to examine draft webpages, provide feedback on their experiences accessing various data, and offer suggestions on content.

In the October 2022 EAC meeting, PSRC staff reviewed what we heard from members regarding the draft webpages and how the feedback was shaping development. We also discussed the new PSRC website, data preparation work to help improve measurements of disparities, and research on environmental and climate-related data.

In this June session, PSRC staff will report on development progress made since October. They include new draft webpages within the framework of the new PSRC website and updates on data indicators.

Next Steps

PSRC staff will continue to develop the Equity Tracker and engage with EAC members again when we have updates.

SUBJECT: Equity Planning Resources for Comprehensive Planning – Next

Steps

IN BRIEF

A year ago, PSRC staff introduced the Equity Planning Resources component of the Regional Equity Strategy implementation work and received feedback from the Equity Advisory Committee (EAC) on the approach for this project. Since then, staff have worked on Phase 1 of the project, consulting the EAC at key milestones for input. At the June meeting, PSRC staff will provide an update on Phase 1 and ask for input from the committee on Phase 2 of this work.

DISCUSSION

The purpose of the Equity Planning Resources is to support integrating equity considerations and measures into local plans and policies. Phase 1 of this work was focused on developing resources specifically for comprehensive plans, a key piece of local planning work that sets priorities for a jurisdiction and guides ordinances, zoning, and other policies consistent with VISION 2050. Updates to comprehensive plans are certified by PSRC and must be completed by December 2024.

The full draft of the <u>Equity Planning Resources for Comprehensive Plans</u> document was posted on PSRC's website in early May. The resources include local examples, policy guides, and data resources to advance equity-oriented policies in VISION 2050. Staff are in the process of finalizing the document and will share how committee feedback was incorporated in the project and the approach for sharing resources with local planners throughout the region.

Feedback from the EAC last year indicated there may be more work to the Equity Planning Resources beyond guidance for comprehensive plans, acknowledging there are other plans and planning processes where equity could be better addressed. Transportation planning processes, with an emphasis on transit equity, were identified

as a potential area of focus. Staff will continue this conversation with the EAC at the June meeting and begin scoping out Phase 2 work.

Next Steps

Staff will finalize Equity Planning Resources for Comprehensive Plans, completing Phase 1 of this project, and begin scoping for Phase 2 based on feedback from the EAC.

SUBJECT: Public Participation Plan

IN BRIEF

PSRC staff have developed a draft Public Participation Plan with input from agency boards and committees. The <u>draft plan</u> was reviewed by PSRC boards this spring before being released for public comment from March 23 to May 8, 2023. Staff will update the EAC on the public comments received and the next steps to finalize the plan.

DISCUSSION

Public Participation Plan Background

The Puget Sound Regional Council maintains a Public Participation Plan to establish consistent procedures to ensure people have opportunities to be involved in the regional planning process and provides examples of the types of tools and techniques the agency may use to communicate with the public. It is a technical document that serves as a blueprint for PSRC's engagement strategies, detailing the approaches and resources that are available to PSRC project managers. Public Participation Plans are a federal requirement for Metropolitan Planning Organizations. The goal of the Public Participation Plan is to clearly describe the methods with which PSRC staff members will engage the public on future projects. The Public Participation Plan was last updated in 2018.

Update Process

PSRC staff members began the Plan update in Summer 2022. The update process built off the work of the Inclusive Engagement team of the Regional Equity Action Plan to include updated goals, desired outcomes, and guiding principles, as well as a suite of new techniques and best practices for engagement. These additions were shaped with EAC feedback from the July and December 2022 meetings.

The draft Plan was presented to PSRC Policy Boards before being released for public comment by the Executive Board in March 2023. The public comment period also included focus groups and direct interviews with engagement professionals throughout

the region who are well-versed in outreach techniques and could comment specifically on the agency architecture for public participation.

Comment Themes

The following themes emerged from our engagement to the policy boards, public comment period, focus groups, and direct interviews:

- Positive feedback on the increased focus on equity. Plan outreach showed an
 appreciation for the increased attention to equity in the goals, desired outcomes,
 guiding principles, and best practices for equitable engagement.
- Relationship building with community-based organizations. Many comments
 encouraged PSRC to continue building inroads with community-based
 organizations throughout the region to empower their existing efforts in engaging
 community. This was especially discussed at our focus group with engagement
 professionals, all of whom stressed the importance of co-creating engagement
 strategies alongside organizations already embedded in communities.
- Oral public comment at PSRC Board meetings. One commenter suggested we move to written only comment for PSRC Board meetings.
- Research pools. One commenter suggested PSRC use a research pool for providing regular feedback on agency activities.
- Other: a few commenters shared interest in PSRC's other activities related to transportation and open space that were not relevant to the Public Participation Plan.

Questions for the Equity Advisory Committee

- Are there any additional comments on the agency framework for Public Participation moving forward?
- Do you have any questions or suggestions about how to make our public comment periods open and inclusive spaces?
- What other practices can we consider in our long-term plans to engage with community members?

Next Steps

PSRC staff will incorporate the edits from our public comment period into the final Public Participation Plan. This document will be presented to the Executive Board later this month with the request that the Board approve the final Plan.
