

Sound Choices Checklist

The checklist is a voluntary tool that helps you evaluate your comprehensive plan for habitat protection and stormwater management goals and polices that align with Puget Sound recovery.

It links to PSRC's Guidance on Integrating Stormwater Solutions into Comprehensive Plans, which provides a deeper dive into the stormwater related topics with examples and model language.

The Habitat Strategic Initiative Lead (HSIL) and partners updated the Sound Choices Checklist to align the Puget Sound recovery priorities with elements and topics included in comprehensive plans.

Partners, including PSRC, Commerce, WDFW, Puget Sound Partnership, and the Stormwater Strategic Initiative Lead, as well as local planners, provided feedback during the update process.



Sound Choices Checklist Purpose

Resource for local jurisdictions updating their comprehensive plans:

- Encourage local jurisdictions to align their comprehensive plan updates with the Puget Sound Action Agenda.
- Help jurisdictions recognize how their decisions and planning policies are advancing Puget Sound recovery. Enable jurisdictions to incorporate Puget Sound recovery and Action Agenda strategies into their planning decisions.
- Provide the Puget Sound recovery community with a resource to use when making comments on local Comprehensive Plan updates.

Department of Ecology Stormwater Management Grant Programs


- Stormwater Capacity Grants: Non-competitive grants awarded to Phase I & II NPDES permittees for implementation. Closes Sept 30th
- Water Quality Combined Funding Program: Stormwater Financial Assistance, State Revolving Fund Loans, Non-point Projects. Closes Oct. 12th
- * Regional-Statewide Significance

 Stormwater Grants: Competitive grants that assist permittees in completing projects that will benefit multiple permittees.
