What is the Public Transportation Plan and why are we updating it?

- The plan moves our state toward a more integrated, multimodal transportation system that meets the needs of growing and thriving communities.
- The plan guides public transportation priorities, planning, and investments in Washington.
- We need to update the 2016 plan so that it reflects the conditions that have changed since it was published.






Three new studies in 2023

- Non-driver study
- Frequent transit service study
 Unmet needs study

All three mention public transportation as a builder of strong communities that provides access to jobs, healthcare, and community.





High-level findings

Public transportation services do not exist everywhere and are not adequate anywhere for all riders.

Access to transportation services and ease of use varies based on race, age, disability status, geography, and income level.

Transportation issues and burdens disproportionately affect vulnerable populations.



High-level findings (cont.)

Improvements to mobility can be made with adequate resources, coordination between levels of government, and adaptive planning.

Although infrastructure barriers to transit trips exist for nondrivers, these barriers can be prioritized and specifically targeted.

Critical access to transportation is provided by other forms of mobility besides fixed route, such as demand response, paratransit, walking, biking, and rolling.



Data findings

500,000 people over 16 do not have a driver's license.

34% of households fall below the ALICE threshold.

10% of people in poverty.

45% of non-drivers will skip going somewhere or be late because of transportation issues.

29 million trips are not taken due to transportation issues.



29 million forgone trips

Lost opportunities to thrive:

- Lack of access to jobs, education, healthcare, and housing.
- Isolation and lack of belonging in the community.

Potential paths forward

Low-income populations ride for free.

Frequent and weekend service.

Regular intercity and rural service.

Jobs and affordable housing located together.

More walking and biking paths and transit-friendly roadways.

More demand-response service.
