MINUTES Growth Management Policy Board November 2, 2023 Hybrid Meeting

CALL TO ORDER

The meeting was called to order at 10:03 a.m. by Councilmember Megan Dunn, Vice-Chair.

COMMUNICATIONS AND PUBLIC COMMENT

There was no public comment.

CHAIR'S REPORT

Vice-Chair Dunn welcomed new board members from the Thurston Regional Planning Council, Commissioner Chris Stearns and Marc Daily.

Vice-Chair Dunn thanked departing and retiring representatives Helen Wheatley, Mayor Joe DePinto and Councilmember Phillippa Kassover for their work on the board.

DIRECTOR'S REPORT

Growth Management Director Paul Inghram gave updates on transportation project selection changes and the upcoming process, climate reduction grants, noted the departure of Laura Benjamin-LaPitz and gave office move updates.

CONSENT AGENDA

2023 HOUSING MONITORING REPORT

PSRC Associate Planner Eric Clute provided an overview of the 2023 Housing Monitoring Report which included information on housing affordability challenges for both ownership and rentals, housing stock and needs and progress in Olympia on several housing bills. PSRC will provide a one-pager on the report in a follow-up email to the board. Eric received feedback from the board on the usefulness of the data in the report and the availability of specific tools provided by PSRC to help address issues brought up in the report.

INDUSTRIAL LANDS ANALYSIS UPDATE

PSRC Economic Development Program Manager Jason Thibedeau presented a regional Industrial Lands Analysis update which included a recap of stakeholder feedback, industrial lands inventory, industrial employment trends, demand for industrial spaces, the industrial work force and next steps. A final report and supplemental materials will be available in the first quarter of 2024.

REGIONAL CENTERS MONITORING

PSRC Senior Planner Maggie Moore updated the board on the regional centers work program. PSRC is currently preparing to define data needs and components of the 2025 monitoring and redesignation process. Maggie engaged the board on what they thought would be helpful to know about regional centers and what other data might be needed for successful monitoring and redesignation. Based on the board's feedback, staff will produce a scope of work for the centers monitoring process which will be brought back to the board in early 2024.

Subject: **Black Home Initiative**

IN BRIEF

The board will be briefed on the [Black Home Initiative](#) (BHI), a new regional effort that seeks to target the racial inequities in the housing market to increase homeownership among Black households. Elements of the Black Home Initiative may be valuable for consideration as communities update their comprehensive plans and work to address racially disparate impacts.

DISCUSSION

Forty-two percent of Black households in Washington state have zero net worth. The rate of homeownership for Black households is about half of that for white households. The city of Tacoma reports a loss of more than fifty percent of its Black homeowners in its central neighborhoods since 2007. The displacement of Black families and businesses not only scatters and breaks family connections, but it also ends legacy businesses, erases cultural identity, threatens economic livelihoods and reduces the opportunity of building the intergenerational wealth necessary for a down payment on a home. Homeownership plays a critical role in maintaining these vital elements of economic opportunity and prosperity.

Marty Kooistra, former Executive Director of the Housing Development Consortium of Seattle-King County and former Growth Management Policy Board member, is now at the Seattle Foundation's [Civic Commons](#) as Network Weaver of the Black Home Initiative. Marty will brief the board on BHI, the collective work of a network of nonprofits, private companies, philanthropy, governments and associations focused on increasing Black homeownership. BHI includes a [seven point plan](#) that addresses housing production, lending, purchasing and existing owners.

Short-term goals include an effort to create opportunity for 1,500 new low- and moderate-income Black households to own a home in South Seattle, South King County, and North Pierce County within the next five years.

Marty will review the key elements of the BHI plan and seek board input on how cities and counties can best support housing ownership opportunities.

Next Steps

As part of the implementation of the Regional Housing Strategy, PSRC will continue to monitor housing ownership metrics and coordinate with the Black Home Initiative and Civic Commons. Staff will update the board on BHI work as it progresses.

Subject: **Covenant Homeownership Act**

IN BRIEF

The board will be briefed on the work of the state [Housing Finance Commission](#) to support access to home ownership and affordable housing, including the implementation of the Covenant Homeownership Act. The work of the Housing Finance Commission may be important for communities to identify as a strategy to address barriers to affordable housing.

DISCUSSION

The Housing Finance Commission is a publicly accountable, self-supporting organization dedicated to increasing housing access and affordability to the people of Washington state. It provides a key connection between affordable housing providers and housing finance tools.

Lisa DeBrock, the Commission's Division Director for Homeownership, will review with the board the Commission's work to support homeownership, which includes homebuyer education, connections to home loans and downpayment assistance. The Commission also conducts a land acquisition program to assist nonprofits in purchasing land for affordable housing. For multifamily housing, the Commission supports use of the 9% and 14% housing tax credits and financing for nonprofit housing. The Commission also provides information for lenders, investors, real estate professionals and instructors.

In the spring of 2023, the Washington State Legislature passed the Covenant Homeownership Act. This landmark legislation makes Washington the first state to address the role of government institutions in housing-related racial discrimination. To

implement the Act, the Housing Finance Commission will oversee a research study that will be prepared by the [National Fair Housing Alliance \(NFHA\)](#).

The term “covenant” refers to the racially restrictive clauses used in neighborhoods throughout the state to keep people out based on their race or religion. The Covenant Homeownership Act represents a new commitment to correct this injustice (and others such as redlining) and help families begin building wealth through homeownership.

The new law has two important parts:

1. **A research study** to investigate housing discrimination against marginalized communities in Washington State, what role government institutions have had in the discrimination, the impacts of the discrimination and potential remedies for the impacts.
2. **A new source of funding** for homebuyer assistance from a new \$100 document recording assessment on every real-estate transaction. These fees will be deposited into the Covenant Homeownership Account and fund the Special Purpose Credit Program, which will be designed and implemented based on the findings of the research study.

Next Steps

As communities address the housing requirements of the Growth Management Act, they may seek to identify the programs of the Housing Finance Commission. PSRC will continue to coordinate with the Commission and local jurisdictions during plan updates.

IN BRIEF

The [Regional Transit-Oriented Development Committee](#) (RTODC), an advisory committee to the Growth Management Policy Board, advances a broad, multi-stakeholder coalition to support equitable transit-oriented development and the region's adopted growth strategy. The board will hear an update on the committee's work in 2023 and its 2024 work plan.

DISCUSSION

The committee held four quarterly meetings and hosted a hybrid TOD event in 2023. Key efforts are listed below.

2024 Work Plan

The committee discussed the 2024 work plan at its December 2023 meeting. The discussion focused on how to “put the committee to work” to support state, regional and local efforts such as the implementation of VISION 2050 and the major periodic update to comprehensive plans.

In addition to the topics and tasks identified in the draft 2024 work plan, previous committee feedback identified several principles for how meetings may be structured in the coming year.

- Put the committee to work – each meeting to include work session
- Use breakout groups and Miro board, when possible, to increase engagement and interaction among members
- Structure discussions to call out different roles of committee members – housing professionals, local staff, community-based organizations, etc.
- Ask additional committee members to facilitate discussions when appropriate

Board members will have an opportunity at their January meeting to provide feedback on the committee’s work program.

The committee will begin implementation of the work plan at its next meeting on March 15, 2024.

Subject: **Regional Safety Plan Draft Scope of Work**

IN BRIEF

PSRC staff has developed a draft scope of work outline for a Regional Safety Action Plan, which is being developed through funding awarded by the USDOT Safe Streets and Roads for All (SS4A) Grant Program. The Growth Management Policy Board will be briefed on the scope of work and have an opportunity to provide feedback at the January 4, 2024 meeting.

DISCUSSION

The 2022 Regional Transportation Plan directs PSRC to develop a Regional Safety Plan, including actions, targets, and performance indicators. It also directs PSRC to seek resources for regional and local planning and projects and, going forward, to use the Regional Safety Plan to help inform future regional and local planning.

The Federal Bipartisan Infrastructure Law (BIL) adopted in 2021 established the new SS4A discretionary program with \$5 billion in appropriated funds over five years. In 2022, PSRC, in coordination with the Cities of Burien, Everett, Kent, Redmond, Tukwila, and Pierce County applied for and in February 2023 was awarded \$4.9 million for safety planning. PSRC is using its portion of grant funding to develop a Regional Safety Plan.

To better understand expectations and goals for the Regional Safety Plan, for the first time PSRC held a Regional Safety Summit on June 29, 2023. Approximately 140 participants gathered at the Seattle Convention Center to discuss transportation safety issues, challenges, and opportunities facing the region.

Feedback received from Summit attendees and other engagement efforts will inform the development of a comprehensive, data-driven Regional Safety Action Plan that will

follow a Safe System Approach for equitable and impactful progress on achieving the safety goals across our diverse four-county region.

Responding to these themes, as well as to Safety Plan components required by USDOT under the provisions of the SS4A planning grant, PSRC has developed a draft scope of work outline for a Regional Safety Action Plan with the following sections: Overview; Safety and Equity Analyses; Engagement and Collaboration; Strategies, Countermeasures and Actions; and Implementation and Next Steps. The full scope of work is included in Exhibit A.

NEXT STEPS

PSRC will work with a consultant team to advance the development of the Regional Safety Action Plan, with a target completion date by Q1 of 2025. There will be additional engagement and outreach opportunities throughout the process.

Subject: **Draft Supplemental Biennial Budget and Work Program (FY2024-2025)**

IN BRIEF

At its January meeting, the Growth Management Policy Board will be given information on the Draft Supplemental Biennial Budget and Work Program FY2024-2025.

BACKGROUND

PSRC's Biennial Budget and Work Program was adopted in May 2023 and covers July 1, 2023 through June 30, 2025.

The proposed supplemental budget reflects revenues and expenditure of \$44,837,000, including approximately \$9.8 million in increased carryover grants from the previous biennium that have been added since adoption in May 2023. As a reminder, grants are awarded on a reimbursement basis and are earned only after completion of the work. A full draft budget is available online at <https://www.psrc.org/about/budget>.

Throughout the month of January, the draft supplemental budget information will be provided to the Executive Board, Economic Development Board, Growth Management Policy Board, Transportation Policy Board, and the Regional Staff Committee. PSRC staff will bring any comments received to the February 22nd meeting of the Operations Committee. In March the Operations Committee will be asked to recommend approval of the budget by the Executive Board and in April, the Executive Board will recommend the budget for adoption by the General Assembly to be held May 30, 2024.
