Subject: Plan Review Work Plan and Approach

#### IN BRIEF

PSRC staff will brief the committee on the process for reviewing and certifying 2024 comprehensive plan updates.

#### **BOARD CALENDAR**

This topic is scheduled for discussion by the Growth Management Policy Board at their meeting on June 6<sup>th</sup> and by the Executive Board at their meeting on June 27<sup>th</sup>.

#### DISCUSSION

Each of the region's 82 cities and towns and four counties are updating their local comprehensive plan to continue shaping their community and planning for growth. Comprehensive plans are 20-year plans for growth, are intended to create a meaningful, community-driven vision for local communities, and collectively plan to address interconnected regional issues. State law requires PSRC to review and certify local comprehensive plans.

Within the central Puget Sound region, local governments and PSRC have worked together to develop an overall process (<u>Adopted Policy and Plan Review Process</u>) for reviewing and certifying local, countywide, regional, and transit agency policies and plans. PSRC reviews local comprehensive plans for consistency with <u>VISION 2050</u>, the <u>Regional Transportation Plan</u>, and aspects of the Growth Management Act.

With the adoption of VISION 2050, PSRC updated the <u>Plan Review Manual</u> to reflect updated regional policies and provide details on how plans and policies are reviewed

and certified. The manual provides guidance and VISION Consistency Tools for aligning plans and policies with VISION 2050 and requirements in state law.

PSRC's review of plans takes place in two stages. PSRC staff review draft plans before adoption, which includes reviewing for consistency with the <u>VISION 2050 Consistency</u> <u>Tool</u>, meeting with local staff, and providing comments on areas for improvement. Once a plan is adopted, PSRC staff will review for consistency and provide a draft report with a certification recommendation, along with comments for future work. The Growth Management Board and Transportation Policy Board will make certification recommendations to the Executive Board. The Executive Board will make the final decision on certification for local comprehensive plans.

At the May meeting, staff will provide the committee an update on the plan review process, highlight early findings from draft plans, and discuss the certification process.

#### NEXT STEPS

PSRC staff continue to review and comment on draft comprehensive plans. Once comprehensive plans have been adopted, PSRC's boards will consider certification recommendations.

#### Subject: Household Travel Survey Program

#### IN BRIEF

Staff will present early insights from the 2023 household travel survey (HTS) data and provide information about the upcoming 2025 HTS.

#### **BOARD CALENDAR**

This topic is not scheduled for policy or Executive Board meetings and is intended to provide regional staff an overview of upcoming work in the PSRC household travel survey program, and highlight an opportunity for members to purchase 2025 "add-on" data samples focused on their jurisdictions or areas of interest.

#### DISCUSSION

PSRC started a new eight-year, four-wave <u>Household Travel Survey (HTS) Program</u> in 2023, following a successful six-year, three-wave HTS program to collect activity and travel data from the region's residents in 2017, 2019, and 2021. This data resource supports agency planning work, including the development of PSRC's regional land use and travel forecast models, and the monitoring of behavioral trends.

Data from the 2023 HTS wave was published in April 2024 on the <u>PSRC Data Portal</u>. In this May RSC meeting, staff will provide early insights from the 2023 data to reveal select trends since the COVID-19 pandemic.

In addition to analyzing the 2023 data, staff is working on the data collection plan for the 2025 HTS wave. Once again, PSRC will provide an opportunity for member agencies to purchase 2025 "add-on" data samples focused on their jurisdictions or

areas of interest. PSRC plan to extend the existing contract for consulting services to perform the data collection work and expect the project to begin in the fall. Commitments for add-on purchases from members in the form of executed memorandums of agreement with PSRC are required prior to project commencement. Data collection will take place in spring 2025 and data processing will last through summer and fall. Data delivery is expected in winter 2026.

#### **NEXT STEPS**

Staff will keep the committee updated on results from the 2023 HTS and progress on planning for the 2025 HTS.

Subject: Washington Geological Survey Resources

#### IN BRIEF

Tricia Sears and Alex Steely from the Washington Geological Survey (WGS) will provide an overview of WGS and share resources WGS has available to support planning and decision-making, including planning for geologic hazards.

#### **BOARD CALENDAR**

This topic is not scheduled for policy or Executive Board meetings and is intended to provide regional staff an overview of a general planning resource useful to the development of local comprehensive plans.

#### DISCUSSION

Washington Geological Survey (WGS) scientists are experts in many aspects of geology. Much of the work includes a focus on geologic hazards, mineral resources, and climate resilience. WGS works with planners, geologists, and other professionals in local, state, and tribal jurisdictions to share reports, maps, and other geologic products, and engage in outreach. The products and outreach support decision-making across multiple levels of government across Washington State.

In Washington State, the most significant geological hazards are earthquakes, tsunamis, volcanic events, and landslides. Other geologic hazards include subsidence above improperly reclaimed mines and exposure to hazardous minerals like radon. Climate change and human alteration of the environment exacerbate the impacts of natural hazards on people, property, and infrastructure, increasing the need for hazard identification and efforts to minimize risk and mitigate impacts.

GMA requires local governments to adopt comprehensive plans and development regulations to guide future growth and development. Comprehensive plans and development regulations help shape land use, natural hazards mitigation, emergency management, and other decisions that take into account factors such as, but not limited to, geologic hazard locations.

There are at least three key areas in GMA that WGS can provide more collaboration and technical assistance on: critical areas (which contain geologically hazardous areas), best available science, and mineral resource lands.

Landslides are one of the multiple geologic hazards WGS researches. WGS recently published an updated *Landslide Hazard Mapping in Washington Fact Sheet*. The <u>Fact</u> <u>Sheet</u> describes WGS landslide hazard mapping. Lidar-based landslide hazard mapping assists land-use planners, emergency managers, public works staff, and those who live and work where landslides could impact their daily lives.

Subject: Industrial Lands Analysis Update Report

#### **IN BRIEF**

Staff will provide the Regional Staff Committee with a recap of the project timeline and key findings for the recently released draft regional Industrial Lands Analysis update.

#### **BOARD CALENDAR**

This topic was reviewed by the Growth Management Policy Board at their meeting on May 2<sup>nd</sup> and is scheduled as a discussion item on the June 5<sup>th</sup> Central Puget Sound Economic Development District Board meeting agenda.

#### DISCUSSION

In 2015, PSRC developed an Industrial Lands Analysis that assessed economic activity on industrial lands in the region and analyzed the region's ability to accommodate economic growth on industrial lands. VISION 2050 and the 2022 Regional Economic Strategy (RES) both include calls to update the Regional Industrial Lands Analysis to refresh the inventory of industrial lands, evaluate supply and demand for industrial land across all industry sectors, and research trends for industrial uses as technology and markets evolve.

In 2022, PSRC staff began stakeholder outreach to help identify trends in the region's industrial lands and gather insights into the development of the Industrial Lands Analysis update. This included a survey of local jurisdictions and other governments with industrial land assets to gather perspectives on trends that are impacting industrial lands. Interviews were conducted with staff from regional cities, counties, ports, and tribal governments, as well as peer regional governments in California and British

Columbia to better understand recent trends. In addition, discussions on trends and key findings were held with regional board and committees including the Growth Management Policy Board, Economic Development District Board, Regional Staff Committee, Freight Advisory Committee, and the Transportation Choices Coalition's Community Partners group.

Throughout 2023, staff provided updates on data and findings to provide opportunities to hear from elected officials and local staff on the industrial trends that their communities are experiencing. In late 2023, PSRC staff worked to further validate findings through outreach to regional stakeholders to gather qualitative and quantitative information to validate and provide context to the industrial lands inventory and the regional industrial trends identified in the report. Staff last shared an update on the industrial lands analysis update project with RSC at its October 2023 meeting.

Staff developed a draft report which includes a regional industrial lands inventory and analysis of key regional trends which was released in April 2024. Findings from the analysis fell into the following categories:

- **Supply of Industrial Lands:** Concerns regarding the availability of industrial lands to meet the current and future needs of industry.
- **Positive Drivers of Demand:** Historic industries continue to drive demand on industrial lands, as well as the emergence of newer sectors.
- **Incompatible and Undesired Uses:** Continued pressure for incompatible and less desirable uses on industrial lands.
- **Impacts to Communities:** Activities on industrial lands having impacts on regional residents, tribes, and the environment.
- **Maintenance Costs:** Challenges that jurisdictions face related to the costs of maintenance of industrial lands.
- **Workforce:** Current and projected shortages of workers for industrial activities and demographic representation in this workforce.
- **Transit Investments:** Potential benefits and challenges of new high-capacity transit investments.
- **Goods Movement:** The impact of increasing traffic on the region's industrial supply chains.

#### **NEXT STEPS**

The draft regional Industrial Lands Analysis update is available on the project's <u>web</u> <u>page</u>, with release of the final report targeted for summer 2024. PSRC encourages jurisdictions to use the regional and manufacturing center industrial lands information both to complete their comprehensive plan updates and to continue to plan for employment growth in their communities.
