Terminology

 Specialized transportation services are transportation programs designed for people who have difficulty transporting themselves due to age, income, or ability.



 "People with accessibility and mobility needs" refers to older adults, youth, people with disabilities, people with low incomes, people with limited English proficiency, and others.


PSRC's Roles

- Planning for specialized transportation programs that serve priority populations.
- Develop the Coordinated Mobility Plan (meets the requirements of the Coordinated Transit-Human Services Transportation Plan).
- **Distribute regional priority rankings** for the State Consolidated Grant program.




Coordinated Mobility Plan

- Includes information on population trends.
- Identifies transportation needs of the people with accessibility and mobility challenges due to their age, income, or ability.
- Outlines **prioritized strategies** addressing the needs.
- Provides a **regional inventory** of existing transportation programs.





By 2050, 21% of the region's population will be 65 or older




PSRC Population Forecasts by Age Group

Demographic Intersections

People with Disabilities with Low Incomes, 2019



People with disabilities are overrepresented in low-income and unemployed populations.

- **32%** of people with disabilities have low incomes.
- The unemployment rate of people with disabilities was **8.1%** vs. those without disabilities at 3.6%.



Addressing Intersectionality

The Coordinated Mobility Plan addresses equity and inclusion by:

- Incorporating people of color in conjunction with age, income, and ability.
- Highlighting the mobility needs of the historically marginalized and underserved communities, identified through engagement.

Specialized Transportation Program Inventory

An online survey conducted in spring 2024:

- Reached transit and specialized transportation agencies, and received information from 44 programs.
- Coordinated with WSDOT and Hopelink (One-call One-click travel planner).
- Currently working with agencies for additional data collection.



Inclusive Engagement

Phase I (Fall 2024) Phase II (Spring/Summer 2025)



Review feedback and data to assess the **transportation needs** of priority populations. **Develop prioritized strategies** based on feedback.

Outreach continues

Key Mobility Needs identified in the Plan

- Shorter travel and transfer times.
- More services at times when they are needed.
- Accessible information about available services and language services.
- Better access to **health and wellness** destinations.
- Affordable transportation for families with low incomes.
- Connected ADA-accessible infrastructure.
- Better regional coordination to meet growing mobility needs.



Regional Priorities for Consolidated Grant

- WSDOT manages and allocates the Consolidated Grants for transportation programs, including specialized transportation.
- PSRC recommends priority projects for the state's evaluation.
- Projects are expected to address PSRC's Coordinated Mobility Plan in applications.
- For this year's process, PSRC worked with the Special Needs Transportation Committee and Equity Advisory Committee to elevate equity throughout the prioritization process.

Fall 2024: Phase 1 engagement kicks off

By Summer 2025: Phase 2 engagement continues

Winter 2025-Early 2026: Draft plan release for comment

Spring 2026: Coordinated Mobility Plan adopted as part of 2026-2050 RTP
