


## Region's Employment Surpasses Pre-Pandemic High

## Central Puget Sound region gains over 34,000 jobs in 2023

Three years after the arrival of the COVID-19 pandemic in the central Puget Sound, 2023 employment data shows that the region surpassed its prepandemic employment high of 2.13 million jobs. By March 2023, regional employment had passed the old employment high mark by around 30,000 jobs, hitting a new regional employment high of 2.16 million jobs.

Over 130,000 jobs, or more than 6.1% of total employment, in the central Puget Sound region were lost between 2020 and 2021, erasing roughly three years of growth. Employment in the region had nearly recovered by 2022 with an estimated gain of over 126,000 jobs, or 6.3%, over that year. Job growth in 2023 continues the central Puget Sound's long-term job growth.

While employment in all four counties of the central Puget Sound region experienced growth between 2022 and 2023, Snohomish County remained below its 2020 employment high by 2,000 jobs in 2023. Of the central Puget Sound's four counties, Snohomish County experienced the greatest employment reduction at an over 8% decline in jobs between 2020 and 2021. This was in large part due to a 19% contraction of the county's manufacturing workforce.

While manufacturing jobs have begun recovering, the sector employed 15% less workers in 2023 than in 2020 in Snohomish County. Regionwide, manufacturing employed 11% less people in 2023 than the sector did in 2020. Other sectors that have yet to employ as many people as they did in 2020 include government and education, which are respectively employing 2% and 3% less people in 2023 than they did in 2020.

This dynamic also exists in retail employment; however, that statistic is an artifact of the federal government reclassifying jobs in the retail and service sectors in 2022. This classification change is reflected in employment estimates that show a major decline in retail employment and a similarly sized increase in services employment between 2021 and 2022.

Overall, 2023 saw widespread job growth, with employment in most sectors growing by 1-2% between 2022 and 2023. One exception has been Finance, Insurance, and Real Estate (FIRE), where the sector's employment saw a 2% decline between 2022 and 2023 in the region.

While total employment had recovered in 2023, analyses by geography and sector show areas that have yet to make a full recovery from the effects of the COVID-19 pandemic. PSRC will continue to monitor employment data in the central Puget Sound.

Note: Covered employment refers to jobs "covered" under the state's Unemployment Insurance Program and constitutes 85-90% of total employment. PSRC uses data from March to reduce the impact of seasonality in employment.
