

Project Description

Runner is a flexible and affordable micro transit service in the Gig Harbor, Ruston, and Tideflats areas. It is a real time transit solution for special needs populations such as youth, seniors aged 65 and older, people with disabilities, and families with low incomes.

Gig Harbor Zone-6.9 square mile microtransit zone with a 2020 census population of 12,700 people

Ruston Runner Zone-2.2 square mile microtransit zone with a 2020 census population of 10,900 people

Tideflats Zone-22 square mile microtransit zone with a 2020 census population of 39,000 people





Runner and SHUTTLE


Runner's service area in green overlapping the SHUTTLE service areas in gray. Runner can fill in transportation gaps from the current SHUTTLE service.
