



How regularly did you participate in your countywide transportation forum meetings in 2024?




#### **Experience with PSRC Project Selection**






Which of the following best describes your understanding of the Project Readiness requirements, as updated for the 2024 Project Selection process?





## **Project Finance Requirements**


Which of the following best describes your understanding of the Project Finance requirements in PSRC's Project Selection process?


Do you feel the project criteria questions reflected in the 2024 funding applications **appropriately reflected the priorities** established in VISION and the Regional Transportation Plan?








